viii. Accept the Tooling and Sustainability Award

Ephrata High School was recently awarded a \$13,000 Tooling and Sustainability Award to fund additional work needed to support tasks accomplished during the project phase of previous Computer Science Education Grant Awards. Through this grant, Ephrata High School will purchase two Razer Blade laptops and other equipment to provide students with the opportunity to experience Virtual Reality education & simulations. Through the previous computer science grants, a laptop and headsets were purchased for the initial teacher teaching Intro to Computer Science. In 2022-23, the program will expand to include Intro to Computer Science, AP Computer Programming, Cyber Security, and Video Game Design between two different staff members. Thus, the need for continued technology upgrades. The Intro to Computer Science course has completed lab support through TEALS and successfully transitioned into a self-sustaining course. The Computer Programming, Cyber Security, and Video Game Design will be supplemented through Project Lead the Way (PLTW). The district was recently awarded a matching grant of \$14,000 from PLTW to continue teacher training and curriculum for the additional computer science classes.

Our professional development for teachers provides training, resources, and support to engage students in real-world learning."

With a background in computer science and experience with PLTW, Scott Sandberg recently applied for a PLTW Computer Science Grant and was awarded \$14,000. He will be teaching Cybersecurity and Computer Programming at EHS this fall. The grant details are as follows:

x. Out of State Travel for CTE

CTE Requests permission to travel to the Association of Career and Technical Education National Conference in Las Vegas, November 30 - December 3rd. Recruitment, Retention, and Training of CTE Educators is a core element of the Comprehensive Local Needs Assessment of the Ephrata CTE Program. The CTE conference gives the Ephrata School District team an opportunity to connect, collaborate and exchange ideas with career and technical educators from across the nation. Funding will include various sources including the CTE ESSER Grant, Perkins, CTE Equity Grant (if granted) and CTE funding as appropriate. The CTE National Conference team will be approximately 12 staff (teachers, administrators, counselors) from the middle school and high school as well as the CTE Director, CTE Coordinator, Curriculum Director & Superintendent. Total costs estimate: \$28,000 for hotel, airfare and registration.
